As the U.S. entered World War II in 1942, it was widely known that America did not have enough airplanes or pilots to fight the war. As factories converted to aircraft assembly, finding enough male pilots for both combat and stateside jobs proved to be a difficult task. In desperation the U.S. created an experimental squadron known as the Women Airforce Service Pilots (WASP) to execute all stateside missions. # Bills Protecting the Value of Your Survivor Benefits

MOAA supports both the Love Lives on Act and the Caring for Survivors Act, both of which address longstanding issues with survivor benefit eligibility and calculation. Additional information can be found <a href="https://example.com/here-at-moaa.">here at MOAA.org</a>.

Here's a brief look at each piece of legislation.

#### **Love Lives On Act**

Surviving spouses who remarry under age 55 risk losing Survivor Benefit Plan payments and Dependency and Indemnity Compensation (DIC). This bill would remove this age restriction. It also would allow survivors to regain TRICARE eligibility if a second marriage ends in death, divorce, or annulment.

#### **Caring for Survivors Act**

DIC benefit rates for survivors of those who die in the line of duty, or of veterans who die of service-connected ailments, have been only minimally adjusted since 1993. They now rest at 43% of a 100% disabled veteran's compensation; this bill would raise that rate to 55%, resulting in about \$450 more per month and matching the compensation percentage offered by similar federal programs.

The bill also allows more survivors who have cared for a disabled veteran to claim DIC benefits. Current law requires a veteran to have been totally disabled by a service-connected condition for at least 10 years in order for a survivor to qualify for DIC. The Caring for Survivors Act would reduce this to five years.

# **Legislative Update**

#### National Level

On Feb. 5, 2025, Congressman Rob Wittman (R-VA-01) joined with Congressman Eugene Vindman (D-VA-07) introduced the <u>Support Military Families Act</u>, which would exempt military spouses who work for the federal government from the federal return to in-person work mandate, ensuring they can keep their jobs and support their service members and families thereby keeping military families together and experienced staff on the job.

This bipartisan legislation was introduced after the congressmen's offices heard directly from Virginians affected by the federal return-to-work mandate, which would have forced many military spouses to choose between their careers in public service and their families.

On Feb. 13, 2025 Congressmen Wittman and Vindman celebrated the administration's newly issued guidance, which heeded the bipartisan call to exempt military spouses from the federal return-to-work mandate. The guidance was issued in a memorandum from the United States Office of Personnel Management (OPM), dated Feb. 12,

Congressman Wittman stated: "I'm proud that our bipartisan Support Military Families Act helped spotlight this critical issue."

Congressman Vindman stated: "Our bipartisan Support Military Families Act directly led to this action that treats the spouses, who sacrifice so much for our nation, with dignity and respect and supports the readiness of our military."

Lt. Gen Brian T. Kelly, USAF (Ret), President and CEO, Military Officers Association of America (MOAA), stated: "MOAA thanks Representatives Vindman and Wittman, along with OPM officials and the wide network of grassroots stakeholders, for their work toward this solution. The federal government's designated position as an 'employer of choice' for military spouses is a strategic one that should continuously be capitalized upon. These protections directly improve overall military readiness and sharpen our warfighting ability while setting the stage for more outreach from public sector employers toward this untapped group of talented workers."

#### State Level (Virginia)

On 5 December 2024, RAC-MOAA hosted its **17**<sup>th</sup> **Annual** Legislative Forum at 0730 and 1500. Thirty-two attendees participated in the two sessions: this included nine legislators and/or legislative staff members. Invited legislators included Virginia Delegates and Senators representing districts within RAC-MOAA's operating territory. The purpose of the Forum was to present the five legislative initiatives put forth by the Joint Legislative Council (JLC) of Veterans Service Organizations. The JLC is comprised of twenty-six Virginia Veterans Service Organizations (VSOs); MOAA is among those twenty-six organizations. Links to the five JLC initiatives are provided below.



Distinguished participants in the Legislative Forum included the Commissioner of Virginia's Department of Veterans Services (DVS) (Charles Zingler), Deputy Commissioner of DVS (Steven Combs), and Chair of the JLC (William Aramony). After the Forum, Commissioner Zingler sent an email to RAC-MOAA and invited legislators commending all for a successful Forum and for their participation.

During the 2025 General Assembly, Chapter members attended several weekly meetings of the General Assembly Military & Veterans Caucus (GAMVC) to monitor progress of the five JLC initiatives. Each weekly GAMVC meeting included the distribution and discussion of a "Bill Matrix" tracking bills of importance to active, reserve, retired military, and veteran personnel. The status of each JLC initiative as of 2/13/25 is provided in the table below. Final outcomes for the 2025 JLC initiatives will be reported in a subsequent newsletter.
